Students and CIWGC Candidates who are Offered
Admission to the Two Year full time Master
Programme in management Studies (MMS) for the
Academic Year 2018-2019.

Selected Candidates are required to comply with the following requirements at the time of payment of payment of tuition fees, failing which their admission offer will be withdrawn / cancelled.

- 1 The admission is confirmed only after all the formalities are completed.
- 2 Certificates to be produced in original, along with two certified photo copies, by **ALL** candidates:
 - (i) Date of birth.
 - (ii) Statement of Marks, Passing & Degree Certificate of Graduation.
 - (iii) SSC (standard X) mark sheet.
 - (iv) HSC / Diploma
 - (v) Qualifying examination mark sheet.
- 3 Certificate to be produced in original, along with two certified photo copies, by **Foreign Nationals and Foreign students** candidates
 - (i) Eligibility Certificates from the Association of Indian Universities, New Delhi (AIU).
 - (ii) Passport of Candidate
 - (iii) Valid student visa of the candidate.
- 4 Certificates to be produced in original, along with two certified photo copies, by **Persons of Indian Origin (PIO)** candidates
 - (i) Eligibility Certificates from the Association of Indian Universities, New Delhi (AIU)
 - (ii) Passport of Candidate
 - (iv) PIO / OCI card
 - (v) Relationship certificate of candidate between parent / guardian.
- 5 Certificates to be produced in original, along with two certified photo copies, by Children of Indian Workers in Gulf Countries (**CIWGC**) and Non-Resident Indian Candidates (**NRI**) candidates
 - (i) Eligibility Certificates from the Association of Indian Universities, New Delhi (AIU).
 - (ii) Valid NRI certificate issued by Indian Embassy.
 - (iii) Passport and visa of parent working in foreign country.
 - (iv) Relationship certificate of candidate between parent / guardian.
 - (v) Letter from employer on company letterhead.
 - (vi) Residence permit or card (address) proof
- 6 Two passport-size photographs / scanned colour photo in pen drive with signature below photograph, as per the format given as (Appendix "A").
- 7 Eligibility: Candidates passing his/her graduation from Universities other than Mumbai University will have to obtain eligibility certificate from University of Mumbai through JBIMS office. If eligibility is not confirmed the admission will be treated as cancelled and no fees shall be refunded.

8. Payment of Tuition Fees: Candidates seeking admission should pay the fees and submit original and attested copies of the documents cited above in Room No. 15, Second Floor latest by 1:00 pm on Monday, August 13th, 2018. Fees should be paid in one installment Only by demand draft drawn in favour of: "DIRECTOR J.B.I.M.S." payable at Mumbai.
