Selected candidates are required to comply with the following requirements at the time of Verification of Documents, failing which their admission will be cancelled.

The admission will be confirmed only after all the formalities are completed.

**Original Certificates along with three\*/five\* self-attested photocopies**

- ◆ Proof of date of birth.
- ◆ Aadhar Card
- ◆ 10<sup>th</sup> & 12<sup>th</sup> Mark sheets and Board Certificates.
- ◆ Statement of Marks of Graduation (semester-wise), Passing & Degree Certificate.
- ◆ Two year's work experience Certificate as an Executive/Supervisor, after declaration of result of graduation is mandatory. Candidate has to produce certificate/s from the Employer/s with a specification of the position held by him/her is of an Executive/Supervisory in nature and also duration as claimed (**excluding probation or internship period**) in the application form.
- ◆ Salary Slips of last Three Months or Bank Statement showing payment of salary.
- ◆ Self-employed candidates are required to submit copies of submission of Income Tax Returns (Last Three years), Registration of the company and/or the copy of the Partnership Deed in which the applicant's name should be mentioned proving the required experience of the candidate. It should be clear from the above documents that the candidate plays a central role in the organization.
