- ❖ After completion of Three Years will get – MMS Three Year Degree

Salient Features of the Programmes

Jamnalal Bajaj Institute of Management Studies (Autonomous) is inviting applications for the MMS (Financial Management/ Human resource Development Management/ Information Management/ Marketing Management) Three Year Degree Programme (According to UGC, the University of Mumbai has changed the nomenclature vide circular No.UG/177 of 2019-20 dated 10th December, 2019 and its Corrigendum No.REG/IIC/2024-25/3 dated 20th June, 2024). “These Master Degree Programmes are approved by University of Mumbai. JBIMS is an Autonomous Department of the University of Mumbai.” The working professionals who have missed the valuable inputs which are obtained by Full Time students of MMS Programme, now can get benefitted by enrolling in MMS (FM/HRDM/IM/MM) Three Year Degree Programme which will help them for the up skilling, better prospects, better performance, effectiveness and efficiency.

- Programmes spread across three years for a steady paced learning.
- Same Course Curriculum as the Full Time Programme.
- **Classes are held in the evening daily from Monday to Saturday 6.30 p.m. to 9.30 p.m. and Sunday full day.**
- Experienced Faculty Members with a combination of industry and academia.
- Enhanced peer networking and learning through group work.
- 75% Attendance is compulsory as per norms laid down by the University of Mumbai.

Eligibility Criteria

- Graduate from any University recognized by UGC or recognized body.
- **Minimum Two Years of work experience after Graduation in Executive/ Supervisory capacity** as on or before **15th June 2026**.
- **Self-employed** candidates are required to submit copies of submission of **Income Tax Returns** (Last Three years), Registration of the company and/or the copy of the Partnership Deed in which the applicant’s name should be mentioned proving the **required experience** of the candidate. It should be clear from the above documents that the candidate plays a central role in the organization.
- Please note that the experience of **Trainee post/ Training period/Probation period** **not be counted in two year’s experience**, in any circumstances.

Selection Criteria

- Admission will be based on the performance of applicants in the selection test
- Selection test consists of “Common Entrance Test”, “Group Discussion” and “Personal Interview”.
- It is mandatory to appear for above all three tests to become eligible for merit list.
- Those who wish to apply for more than one programme, has to apply and pay the fees separately for the different programmes.
- Admission will be given to **ONLY ONE** of the programmes applied, by his /her choice according to merit.
- **Request for change in admission to the different programmes is not allowed after the completion of admission process.**
- **The written test is multiple choice objective type questions test. Questions will be based on comprehension, quantitative ability, logic, general knowledge.**
